The Ritual Practices Committee is hard at work preparing for the High Holy Days Services and I am pleased to present to you the first of our two High Holy Days mailings. This packet contains information and forms for our adult and children's services, acquiring additional tickets, parking, and volunteering at one of the High Holy Days services.

The High Holy Days are early this year and we kindly ask that you return forms **by Thursday, August 13** to give us enough time to process your requests. The second High Holy Days mailing which will include all tickets will be mailed the week of August 23<sup>rd</sup>.

This year, a change that congregants may note is the new children's service time for *Rosh Hashanah*. The Ritual Practices Committee is constantly striving to seek out solutions that will benefit our members young and old. After soliciting feedback following last year's services, the children's *Rosh Hashanah* service has been moved to 9:30 AM, beginning prior to the adult service at 10 AM. The *Yom Kippur* children's service will remain in the afternoon at 1:15 PM. We have also expanded the *Rosh Hashanah* service material to include preschool-age children. We hope to receive feedback following this year's services to determine how successful our programming changes were for Temple David families.

**2. CHILDREN'S SERVICES AND CHILDREN'S PROGRAMMING:**

We gladly welcome children at the High Holy Day Services. During a part of the Rosh Hashanah and/or Yom Kippur morning service, we will be providing an activity period for children in grades Kindergarten through 4<sup>th</sup> grade until 11:30 am. This is a free service. Please see the attached flyer for more information.

Since our High Holy Day Services are conducted on an adult level, we provide a special children's service on both Rosh Hashanah and Yom Kippur. These services are intended for children ages 2 through 4<sup>th</sup> grade and provide an excellent introduction to the congregational worship experience. The Rosh Hashanah service will be held in the morning prior to the adult service, which is a change from past years. The Yom Kippur service will be held in the afternoon as usual. Each service lasts approximately 30-45 minutes and includes liturgical material appropriate to this age group. Following the Rosh Hashanah children's service, it is our custom to celebrate the "Birthday of the World". We also invite parents and children to attend the *Tashlich* service at Valley Park following the children's service. Following *Tashlich*, everyone is invited to Rabbi Symons' home for dessert. No reservations are needed for these services or activities.

**BABYSITTING:**

Also on Rosh Hashanah and/or Yom Kippur mornings, the Sisterhood will be offering babysitting for children ages infants – 4 years. This is a paid service. Please return your reservation form and money before **September 8, 2015.**

3. **TICKETS: A NON-TRANSFERABLE TICKET** is being sent to each member and guest.

**PLEASE NOTE:** For the safety and protection of our congregants and guests, Monroeville police will be checking tickets as individuals enter the Temple building. ***It is therefore essential that you bring your 2015 High Holy Day ticket with you for EVERY service.*** High Holy Day tickets will be mailed the week of August 23, 2015.

**Children 17 and younger do not need tickets to enter High Holy Day services.** To obtain High Holy Day tickets for **dependent** children 18 years of age or older (**including college students**) please complete the form enclosed in this mailing. *Tickets will be issued at no charge to unmarried children of Temple David members who are full-time students and to members of the armed forces.*

In addition, Temple David will extend reciprocity to family members of Temple David congregants affiliated and in good financial standing with any congregation (Reform, Conservative, Reconstructionist and Orthodox). **Letters of financial standing must accompany ticket requests.** This letter should also state whether or not High Holy Day tickets are included in membership. If the home congregation requires the purchase of High Holy Day tickets in addition to annual dues, proof of purchase from an officer of that congregation must accompany the ticket request to Temple David Congregation. **If a family member will be using a reciprocal ticket, please call the Temple Office at 412-372-1200, Monday through Friday 9 a.m. – 3 p.m., and give Beverly your name and the name of the family member. We will also need to know where to mail the tickets.**

Members who are aware of unaffiliated Jewish families are requested to acquaint them with the availability of membership or guest tickets through the Temple Membership Committee. ***Please note that our dues for members 30 years old and under are \$72.00 for a single member and \$144.00 for a family membership. High Holy Day Tickets are included with your membership.*** Please contact Rachael Farber (412) 243-8392 or Andy Schmitt (724) 327-6494 for further information.

Please have all requests for tickets to the Temple David office **no later than August 13, 2015.** All ticket requests should be accompanied by payment in full. Individual circumstances will be considered by the Financial Committee where necessary.

4. **LISTENING ASSISTANCE:** We want all attendees to share in and be part of the High Holy Day services. We have 32 portable units and each includes an earpiece and receiver unit. These devices are compatible with personal hearing devices. These 32 devices will be reserved for use on a first-come, first-reserved basis.

Please call the Temple Office at 412-372-1200 to reserve one and a unit will be designated for your use for all High Holy Day services. You may pick up your reserved unit at the usher's table next to prayer book distribution. These devices must be returned to the same table after each individual service. **No listening assistance devices will leave the Temple under any circumstances.**

5. **SEATING:** Seating will be on a first-come basis. Please understand that we **cannot** allow "saving of seats" with the exception of one seat for the driver. Therefore, please allow sufficient time to park your car.

6. **PARKING:** For those persons who are physically challenged, special arrangements for parking can be made by calling Beverly at the Temple office, 412-372-1200 from 9:00 a.m. to 3:00 p.m., **no later than September 3 2015.** In order to qualify for handicapped parking, **you must possess a current handicapped license plate or placard.** The license number or placard registration number will be required when calling the office to reserve your space.

Arrangements will be made for a **shuttle bus between another parking lot and Temple.** More detailed information will be included with your tickets.

**Paid Reserved Parking:** Eliminate the hassle of looking for a parking space during the High Holy Days – buy a parking space for these services! To supplement our fundraising, Temple David will sell up to a **maximum** of 15 parking spaces, good for six services for the 5776 High Holy Days: *Rosh Hashanah (Erev, First Day, Second Day)* and *Yom Kippur (Kol Nidre, Morning, and Afternoon)*. Paid parking spaces will be sold on a first-come, first-served basis; please fill out and return the form included in this mailing. All parking passes will be mailed with your High Holy Day tickets.

### **HIGH HOLY DAY REMINDERS**

**REMEMBER YOUR TICKETS.** For the safety and protection of all our congregants, Monroeville police will be checking tickets as individuals enter the Temple building.

**ARRIVE EARLY FOR SERVICES.** Because of the limited number of parking spaces in the Temple parking lot, it will take longer than usual to park your car and be seated before services begin. Please plan to arrive at Temple a **half hour** before services begin.

#### **DO NOT PARK ON LAURA LEE DRIVE OR BERKELEY WAY!**

**PLEASE LIMIT USE OF THE PARKING SHUTTLE TO THE DRIVER ONLY.** Passengers should be dropped off at the Temple main entrance. The driver alone should proceed to the satellite parking location to avoid having large numbers of people waiting for the shuttle bus.

**CONGREGATIONAL PARTICIPATION IS IMPORTANT.** The service belongs to all who attend and everyone is encouraged to sing and to join in prayer. The choir is present to enhance, not to perform.

**PLEASE BE CONSIDERATE OF OTHERS WHEN ENTERING OR EXITING THE SANCTUARY DURING SERVICES.** No one will be permitted to enter and should not exit the sanctuary when the choir is singing, when the congregation is standing, during silent meditation, during the Torah service, chanting of Kol Nidre, during the Yizkor (Memorial) Service and during the Rabbi's sermon.

**CELL PHONES:** Please be courteous toward those sitting near you. Make sure your cell phone is off or on vibrate and please refrain from using your cell phone for talking or texting while in the sanctuary.

**GATES OF REPENTANCE.** If you own copies of *Gates of Repentance* please remember to bring them with you.

**There are a variety of spiritual and educational experiences available for your children and grandchildren during the High Holy Days at Temple David!**

**Children's Service at 9:30am on Rosh Hashanah** The children's service (for ages 2 through 4th grade) will take place from 9:30–10am on the first day of Rosh Hashanah, immediately preceding the adult services at 10 AM. Parents are requested to attend the service if children are age 5 and under. The Rosh Hashanah Children's Service will be led in the Temple David Conference Room by Rabbi Stephanie Wolfe with an introduction from Rabbi Barbara Symons.

After the service, it is our custom to celebrate the "Birthday of the World". Following this celebration, Kindergarten through 4<sup>th</sup> grade children will be divided into age appropriate groups for supervised activities in the classroom wing until returning to the sanctuary for the shofar service. **Children's Service at 1:15pm on Yom Kippur** Rabbi Barbara Symons will lead an interactive service on Yom Kippur afternoon. All are welcome!
